Second Chance

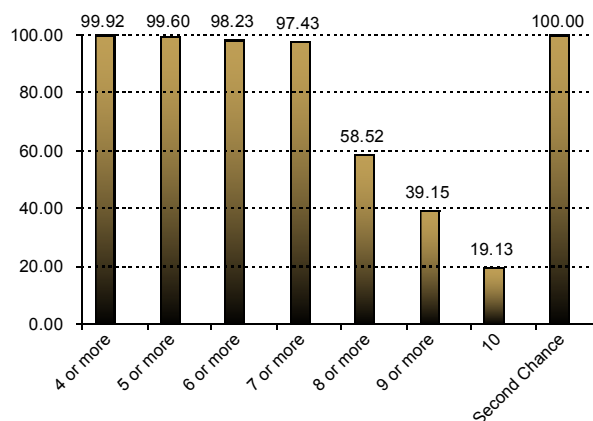

Solid Back Testing

BNP Paribas investment managers have conducted back-testing analysis by observing how many Annual Bonus Payments would have been paid from a typical basket of Win Win stocks. Tracking 1245 10-year periods between January 4th 1988 and October 22nd 2002, they found that in 97.4% of cases investors would have received seven or more Annual Bonus Payments by the tenth year, and that ALL of missed Annual Bonus Payments would have been recouped through the Second Chance feature by maturity. Exceptional Security

The investment is issued and guaranteed by BNP Paribas, one of the world's largest banks, which has an 'AA+' Standard & Poor's long-term financial strength rating.

Not 'Locked In'
